# I. Mission Statement

The general mission of the Department of Criminology at California State University, Fresno, is to offer high-quality educational opportunities to qualified students at the bachelor's degree level. The Department of Criminology's mission statement for undergraduate education includes 1) offering quality academic programs, 2) promoting and enhancing the teaching and learning experience of students and faculty, 3) preparing students for entry into criminal justice system agencies, and 4) preparing students for graduate education. The mission will be accomplished in an environment of mutual respect and support among students, faculty, and staff. The Department of Criminology's undergraduate mission will complement the Department's overall mission and the missions of the College of Social Sciences and California State University, Fresno.

# II. Goals and Student Learning Outcomes

**Goal 1: Discipline-related knowledge:** Students will attain discipline-related knowledge and writing skills that prepare them for long-term careers in Criminology and Criminal Justice.

# Student Learning Outcome 1

Graduates will be able to correctly and accurately define and describe key criminological terms, theories, and specific examples from criminal law, as well as various aspects of the criminal justice system.

**Goal 2: Writing proficiency:** Students will attain basic writing skills that prepare them for long-term careers in Criminology and Criminal Justice.

# **Student Learning Outcome 2**

Graduates will be able to write a paper with appropriate use of skills in mechanics, organization, and format.

**Goal 3: Information literacy:** Students will be able to identify, locate, access, and use information relevant to their inquiries and be able to cite this information appropriately.

# Student Learning Outcome 3

Graduates will be able to access the needed information effectively and efficiently and evaluate the information and its sources critically.

**Goal 4: Critical thinking:** Students will think critically and will apply specific knowledge and skills in order to evaluate situations according to professional values and ethics and make appropriate decisions.

#### Student Learning Outcome 4

Graduates will be able to demonstrate their ability to apply critical thinking to evaluate situations and make decisions in their specific field.

**Goal 5: Methodological and statistical competency:** Understand basic research and quantitative strategies for uses specific to criminal justice and criminology.

#### Student Learning Outcome 5

Graduates will be able to perform data analysis, interpret the findings, and make statistical conclusions.

A. D	rect Measures: (minimum of three required)				
1.	The students' discipline-related knowledge will be evaluated using 30 assessment				
	questions as one of the internship requirements (Outcome 1)				
	Benchmark: 75% or more of the senior students will correctly answer 20 or more				
	questions.				
2.	CRIM 170 research papers: Students will write APA-style papers in CRIM 170. Samples or				
	these will be evaluated according to a rubric to assess writing competency and				
	information literacy (Outcomes 2 and 3).				
	Benchmark: A mean score on the rubric of writing competency/information literacy is				
	considered to have met the learning outcome. Seventy-five percent of students are				
	expected to demonstrate writing competency.				
3.	CRIM 50 in-class work: Students will perform data analysis, interpret the findings, and				
	make statistical conclusions using the SPSS software. Samples of these will be evaluated				
	according to a rubric (Outcome 5).				
	Benchmark: A mean score on the rubric of quantitative competency is considered to				
	have met the learning outcome. Seventy-five percent of students are expected to				
	demonstrate statistical competency.				
4.	CRIM 112/114 in-class assignment: Students will write short paragraphs of three critical				
	thinking questions after reading a newspaper article (Outcome 4)				
	Benchmark: A mean score on the rubric of critical thinking competency is considered to				
	have met the learning outcome. Seventy-five percent of students are expected to				
	demonstrate critical thinking competency.

VI. Time Line for Implementation of Assessment Methods and Summary Evaluations

Year 2018 to 2019

Method 1: Quantitative reasoning will be assessed by the in-class work from the CRIM 50 classes (Outcome 5: Direct measure)

Year 2019 to 2020

Method 1: Employer survey will be distributed to all the agencies that currently take our interns (Outcomes 1, 2, 3, 4, and 5: Indirect measures)

Year 2020 to 2021

Method 1: Writing communication: The term papers written in CRIM 170 will be evaluated with a rubric (Outcome 2: Direct measure)

Method 2: Information literacy: The term paper written in CRIM 170 will be evaluated with a rubric (Outcome 3: Direct measure)

Year 2021 to 2022

Method 1: Exit survey: An online survey will be distributed to all the students who apply for graduation in Spring 2021 (Outcome 1, 2, 3, 4, and 5: Indirect measures)

# Year 2022 t0 2023

Method 1: The critical thinking assessment test will be given during class and a rubric will be used to evaluate the skills (Outcome 3: Direct measure)

#### VII. Process for Closing the Loop

The members of the Assessment Committee, which consists of the department assessment coordinator and three full-time faculty members, are responsible for designing and carrying out assessment activities with the help of the entire faculty as needed. The Assessment Committee also analyzes the resulting data and suggests changes to the program as necessary. Assessment data and suggested program changes will be presented to the entire faculty in the monthly faculty meeting, and the entire faculty decides whether to implement any changes. Further discussions could be carried out at the Department retreat.
